Instructions

1. Members desiring to exercise their vote through the Postal Ballot should complete and sign this Postal Ballot Form and send it to the scrutinizer, **Mr. Alwyn D'souza, of Alwyn Jay & Co.**, practicing company secretaries at **Link Intime India Private Limited**, Share Transfer Agent (STA), at its Registered Office: **C-101, 247 Park, L.B.S. Marg, Vikhroli (W), Mumbai - 400 083** in the attached postage pre-paid self-addressed Business Reply Envelope. Postage charges will be borne and paid by the Company.
2. Postal Ballot Form(s), if deposited in person, or sent by courier, or registered/speed post at the expense of the Member will also be accepted.
3. This Form should be completed and signed by the Member (as per the specimen signature registered with the Company's STA/Depository Participant).
4. In case of joint holding, this Form should be completed and signed by the first named Member and in his/her absence, by the next named Member.
5. The duly completed Postal Ballot Form should reach the Scrutinizer **not later than 5.00 p.m. (IST) on Tuesday, June 12, 2018**. All Postal Ballot Forms received after this date will not be considered and the same shall be treated as invalid.
6. In case of Equity shares held by companies, trusts, societies etc., the duly completed Postal Ballot Form should be accompanied by a certified copy of the relevant board resolution/appropriate authorization with the specimen signature(s) of the authorized signatory (ies) duly certified/attested.
7. The Company is offering an e-voting facility as an alternate option for all its Members to enable them to cast their votes electronically instead of using the Postal Ballot Form. The detailed procedure for e-voting has been enumerated in the Notes to the Postal Ballot Notice dated **April 28, 2018**.
8. There will be only one Postal Ballot Form/e-voting for every Folio/Client ID irrespective of the number of joint holder(s). Voting rights in the Postal Ballot/e-voting cannot be exercised by a proxy.
9. Members are requested not to send any other paper alongwith the Postal Ballot Form in the enclosed postage pre-paid self-addressed Business Reply Envelope, as all such envelopes will be sent to the Scrutinizer and any extraneous paper found in such envelopes would not be considered and would be destroyed by the Scrutinizer.
10. The voting rights of Members shall be in proportion to their Equity Shares to the total paid-up Equity Share Capital of the Company.
11. Consent must be accorded by recording the assent in the column '**FOR**' or dissent in the column '**AGAINST**' by placing a tick mark (√) in the appropriate column in the Postal Ballot Form.
12. Incomplete, unsigned or incorrect Postal Ballot Forms will be rejected. The Scrutinizer's decision on the validity of a Postal Ballot will be final and binding.
13. Members can opt for only one mode of voting i.e. either by Postal Ballot Form or through e-voting. In case you are opting for voting by Postal Ballot, then please do not cast your vote by e-voting and vice versa. In case Members cast their votes both by Postal Ballot and e-voting, the votes cast through e-voting shall prevail and the votes cast through the Postal Ballot Form shall be considered invalid.
